

C-213—Mohler Substation

In TILLAMOOK County, State of OREGON:

C-213 Item: A tract of land in the east half of the northwest quarter of Section 36, Township 3 North, Range 10 West, Willamette Meridian, bounded on the north by Foss County Road; on the west by Sam Tomlinson County Road (No. 313) and on the south and east by that heretofore vacated county road described in Book V, Page 38, Journal of County Court of Tillamook County, Oregon; more particularly described as follows:

Beginning at a point at the intersection of said Sam Tomlinson County Road with said Foss County Road, which point is 1794.14 feet east and 1303.77 feet south of the northwest corner of said Section 36; thence south $53^{\circ} 44'$ east 876.64 feet along said Foss County Road; thence south $52^{\circ} 04' 20''$ east 128.48 feet to a point at the intersection of said vacated county road with said Foss County Road; thence along the center line of said vacated county road south $33^{\circ} 25' 30''$ west 186.85 feet; thence south $50^{\circ} 22'$ west 65.82 feet; thence south $82^{\circ} 56'$ west 79.30 feet; thence north $64^{\circ} 47'$ west 91.88 feet; thence north $49^{\circ} 07' 30''$ west 125.68 feet; thence north $64^{\circ} 36'$ west 257.68 feet; thence north $22^{\circ} 30' 30''$ west 80.95 feet to a point where said vacated road intersects the Sam Tomlinson County Road No. 313; thence north $11^{\circ} 10'$ east 81.06 feet along said Sam Tomlinson Road; thence north $17^{\circ} 48'$ east 158.00 feet; thence north $2^{\circ} 57'$ west 78.10 feet; thence north $45^{\circ} 29' 30''$ west 271.89 feet to point of beginning; SUBJECT to the rights of way of the Foss County Road and the Sam Tomlinson County Road, but including the right of way of the vacated county road referred to above.

C-214—Athena Substation

In UMATILLA County, State of OREGON:

C-214 Item: A tract of land beginning at the southeast corner of Lot 7 in Block 1 of Rose's Addition to the City of Athena, Oregon; thence south on the east line of said Lot 7 extended 70 feet to a point on the south side of Main Street, which point is the true point of beginning for this description; thence south along the east line of Lot 7 extended 270 feet; thence east at right angles to the said east line of Lot 7 extended 158.5 feet, more or less, to the west line of land conveyed to the City of Athena by deed recorded in Book 31, on Page 563 of the Deed Records of Umatilla County, Oregon; thence northerly along the west line of the said City of Athena tract 270 feet, more or
