

Avenue, county road No. 561, and which bears south 445 feet from the northwest corner of Section 4, Township 1 South, Range 3 East of the Willamette Meridian; thence east 586.67 feet; thence south 521.03 feet; thence west 586.67 feet to the center line of Birdsedale Avenue; thence north along the center line of Birdsedale Avenue, county road No. 561, 521.03 feet to the point of beginning.

*D-125 Item 6:* A tract of land beginning at a point in the southerly line of the John Barnes D.L.C. which is 511.5 feet westerly from the most easterly, southeasterly corner of said John Barnes D.L.C., said corner also being the re-entrant corner of the Jeremiah Stanley D.L.C., running thence north 496.32 feet to the southeasterly corner of tract conveyed by Stephen Roberts, et ux, to Robert Dennis Holden by Deed recorded March 14, 1878, in Book 33, Page 157; thence westerly along the southerly boundary line of said Holden tract 346.82 feet; thence south 496.32 feet to the southerly line of said John Barnes D.L.C.; thence easterly along the southerly line of said John Barnes D.L.C. 346.82 feet, more or less, to the point of beginning. Except the rights of the public in and to public roads and highways.

*D-125 Item 7:* A tract of land in Section 5, Township 1 South, Range 3 East of the Willamette Meridian, described as follows:

Beginning at a point on the east line of said Section 5, which is 6 chains north of the southeast corner of said Section; thence west to the east line of the tract conveyed to Oregon Water Power & Railway Co. by deed recorded January 10, 1906 in Deed Book 350 at Page 189; thence northerly along said east line, to the south line of the John Barnes Donation Land Claim; thence north  $89\frac{1}{2}^{\circ}$  east along said south line to the east line of said Section 5; thence south along said east line 18 chains 28 links to the point of beginning, in the County of Multnomah and State of Oregon, subject to the rights of the public in and to that portion of the above property lying within the limits of S. E. 202nd Avenue.

*D-125 Item 8:* The north 60 feet of Lot 1, all of Lot 2, and the south 10 feet of Lot 3 of Ruby, according to the official plat thereof, all in Section 5, Township 1 South, Range 3 East, Willamette Meridian.

*D-125 Item 9:* A tract of land beginning at the southeast corner of Section 5, Township 1 South, Range 3 East of the Willamette Meridian; thence north along the east line of Section 5, a distance of 6 chains to the southeast corner of a tract of land conveyed to John Schramm, by deed recorded December 7, 1888, in Book 110, Page 164, Deed Records; thence west along the south line of the Schramm tract to the easterly line of the Oregon Water Power & Railway Co.
