*D-125 Item 10:* A tract of land in Section 8, Township 1 South, Range 3 East of the Willamette Meridian, in the County of Multnomah and State of Oregon, described as follows:

Beginning at a point in the north line of the Gerhard Linneman Donation Land Claim which is north  $89^{\circ} 52'$  west 1446.58 feet from the northeast corner thereof; thence south  $29^{\circ} 23' 15''$  west 956 feet to a point in the north line of the 40 foot easement and right of way granted to the City of Portland by instrument recorded February 1, 1924 in Deed Book 953, Page 451; thence south  $89^{\circ} 36' 30''$  west, along the north line of said right of way, 519.28 feet to the east line of the tract conveyed to Mary Ellen McMillan by deed recorded December 7, 1910 in Deed Book 521, Page 77; thence south  $0^{\circ} 03'$  west, parallel with the west line of said Linneman Claim, 40 feet, more or less, to an old stone monument marked with an X on top marking an angle corner in the east line of said McMillan Tract; thence westerly 89.63 feet, continuing along the line common with that of said McMillan tract, to another old stone monument; thence southerly continuing along said common line, which is stated to bear  $0^{\circ} 55' 14.9''$  to the right of a line drawn from the last described point parallel with the west line of said Claim, for a distance of 417.44 feet to another old stone monument marking the southeast corner of said McMillan Tract; thence westerly along a line common with the south line of said McMillan Tract, stated to be parallel with the south line of a certain 90 acre tract of land conveyed to Thomas Grant by deed recorded in Book "M" of Deeds, Page 754, a distance of 527.21 feet to a point 50 feet west of the west line of said Linneman Claim; thence south, parallel with said claim line, 20 feet to an old stone monument marked with an X on top which is on a westerly extension of the south line of aforesaid 90 acre tract; thence easterly, along said extended line, 50 feet to said claim line at the northwest corner of a tract conveyed to Iona McColl by Deed Recorded June 17, 1932 in PsDeed Book 176 at Page 407 and which corner is 1958.62 feet north of the stone monument marking the northeast corner of the Giese Donation Land Claim; thence easterly tracing the north line of said McColl Tract and of a tract conveyed to Sam Reichen by deed recorded June 29, 1928 in Deed Book 1149 at Page 215, a distance of 1725 feet, more or less, to the northeast corner of said Reichen Tract; thence south along the east line of said Reichen Tract 3 feet,
