

*D-132 Item 1:* The west 100 feet of the northwest quarter of the southeast quarter of Section 6, Township 12 North, Range 19 East of Willamette Meridian; EXCEPT County Road.

*D-132 Item 2:* The southwest quarter of the southeast quarter of Section 6, Township 12 North, Range 19 East, Willamette Meridian.

*D-133 Line No. 1:* From Casper Substation (C-228) to Dave Johnston Plant (B-10), all in NATRONA and CONVERSE Counties, State of WYOMING, including certain tracts of land used for right of way and described as follows:

*D-133 Item 1:* A tract of land beginning at a point on the east line of Section 29, Township 34 North, Range 79 West of the 6th Principal Meridian, 100 feet north  $0^{\circ} 38'$  west of the southeast corner thereof; thence south  $89^{\circ} 24'$  west 1168.35 feet, more or less, parallel to the south line of said Section 29, to the east line of the Service Pipeline Company right of way; thence north  $12^{\circ} 30'$  east 51.21 feet, more or less, along said east line to a point 150 feet north, measured at right angles, from the south line of said Section 29; thence north  $89^{\circ} 24'$  east 1162.37 feet, more or less, to the east line of said Section 29; thence south  $0^{\circ} 38'$  east along said east line 50 feet to the point of beginning, all in the County of NATRONA.

*D-133 Item 2:* A tract of land, beginning at the southeast corner of the southwest quarter of the southwest quarter of Section 29, Township 34 North Range 79 West of the 6th Principal Meridian; thence west along the section line 1255 feet; thence north 134 feet; thence east 1391 feet; thence in a southwesterly course paralleling the west property line of the Salt Creek paved highway 196 feet to the point of beginning; all in the County of NATRONA.

*D-133 Item 3:* A tract of land beginning at the south quarter corner of Section 29, Township 34 North, Range 79 West of the 6th Principal Meridian; thence south  $89^{\circ} 24'$  west 758.86 feet, more or less, along the south line of said Section 29 to the southeast corner of a tract described in Book 101 on Page 90, Deed Records of Natrona County; thence north 150 feet; thence north  $89^{\circ} 24'$  east 2224.41 feet, more or less, to the west line of the Service Pipeline Company right of way; thence south  $12^{\circ} 30'$  west 153.64 feet to the south line of said Section 29; thence south  $89^{\circ} 24'$  west 1432.3 feet, more or less, to the point of beginning, excepting therefrom the right of way of State Road No. 87, and for roads and/or pipelines, all in the County of NATRONA.

*D-134 Line No. 2:* From Casper Substation (C-228) to Dave Johnston Plant (B-10), all in NATRONA and CONVERSE Counties, State of WYOMING, including certain tracts of land used for right of way and described as follows:
