THE GRANTORS, R. D. HALL and MARTHA HALL, husband and wife now and at the time of acquiring title,

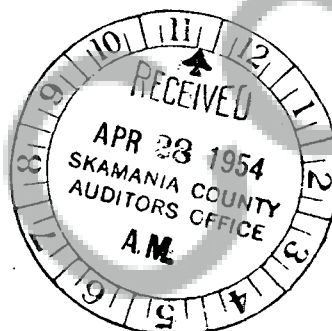
