

J-13 Item 10: The east 100 feet of the west 660 feet of Lot 4 of Section 9, Township 1 North, Range 3 East, Willamette Meridian, SUBJECT to an easement for roadway purposes over the south 60 feet of the above described property.

J-13 Item 11: Lots 16, 17 and 18, Block 2, Blake's Highland Addition to the City of Camas, Washington, EXCEPT the easterly 75 feet of said Lot 18, measured along the northerly line and lying parallel to the easterly line thereof.

J-13 Item 12: Lot 5, Block 4, Blake's Highland Addition to Camas, Washington, according to the plat thereof, recorded in Volume "D" of Plats, Page 107, Records of said County.

J-13 Item 13: Lot 13, Block 2, Blake's Highland Addition to the City of Camas, Washington, according to the plat thereof in Volume "D" of Plats, Page 107, Records of Clark County, Washington.

J-21 Lands in YAKIMA County, State of WASHINGTON:

J-21 Item 9: A tract of land beginning at the northeast corner of the west half of the northeast quarter of Section 9, in Township 10 North, Range 20 East, Willamette Meridian; thence south $89^{\circ} 50'$ west along the north boundary line of said subdivision 50 feet; thence south $00^{\circ} 01'$ west 699 feet to the true point of beginning; thence south $00^{\circ} 01'$ west 200 feet; thence north $89^{\circ} 59'$ west 667.1 feet; thence north $00^{\circ} 10'$ west 200 feet; thence south $89^{\circ} 59'$ east 667.7 feet, to the true point of beginning, EXCEPT the west 60 feet for road purposes.

J-21 Item 10: Section 35, Township 13 North, Range 23 East, Willamette Meridian, SUBJECT to existing rights of way for roads, power and/or telephone lines, canals, ditches and all facilities incident thereto.

J-21 Item 11: The south half of Section 13; all of Section 26; all of Sections 23, 24 and 25, EXCEPT a strip of land 200 feet in width across said Sections 23, 24 and 25, heretofore granted to the United States of America, being 100 feet wide on each side of a line described as follows:

Beginning at a point on the west line of said Section 23, said point lying north 2,575 feet, more or less, from the southwest corner thereof; thence south $65^{\circ} 30'$ east, 5,670.0 feet, more or less; thence along a 1° curve to the left, a distance of 2,050.0 feet; thence south $86^{\circ} 00'$ east, a distance of 1,660 feet, more or less; thence along a 1° curve to the left, a distance of 2,400.0 feet to the point of terminus of the above described line.
