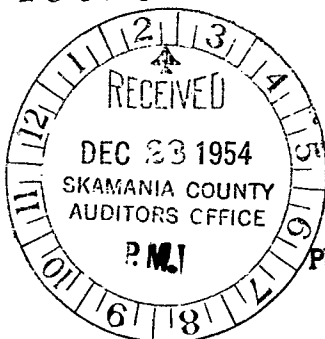

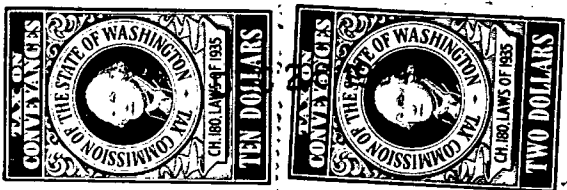
## PURCHASER'S ASSIGNMENT OF TIMBER DEED

The Assignors, T. F. ZACHER and AGNES L. ZACHER, husband and wife, and MYRON PURSLEY and WANDA J. PURSLEY, husband and wife, of Aurora, Oregon, for and in consideration of Ten Dollars and other valuable considerations, in hand paid, hereby assign, transfer, set over, convey, and warrant to BAXCO CORPORATION, a corporation organized and existing under the laws of the State of Oregon, its successors and assigns, all their right, title and interest acquired under that certain warranty timber deed dated May 1, 1954, and recorded December 8, 1954, at page 86 of Book 39 of Deeds, Records of Skamania County, Washington, in and to the following described real property and the timber standing and being thereupon in Skamania County, Washington:

The northeast quarter of the northwest quarter (NE $\frac{1}{4}$  NW $\frac{1}{4}$ ), the west half of the northeast quarter (W $\frac{1}{2}$  NE $\frac{1}{4}$ ), and the northwest quarter of the southeast quarter (NW $\frac{1}{4}$  SE $\frac{1}{4}$ ) all in Section 23, Township 3 North, Range 7 E.W.M.

The Assignors further assign, transfer and set over to the said Baxco Corporation, its successors and assigns, the option set forth in the warranty timber deed aforesaid to extend the time for removal of timber from the above described real property to May 1, 1957; and the Assignors covenant and agree that they will promptly pay all taxes which are required to be paid under the terms and conditions of the said warranty timber deed in the event the said option be exercised.

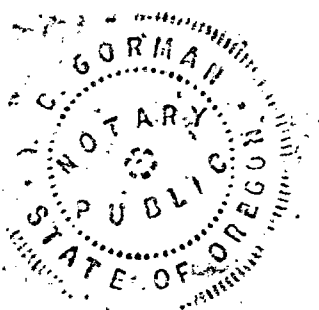

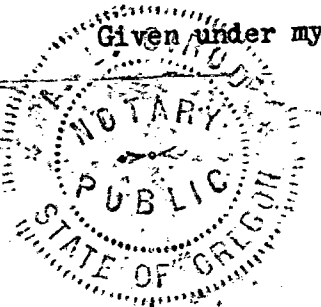
