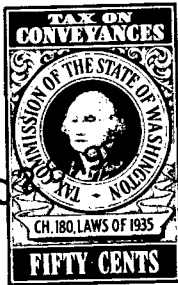
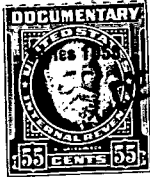

## EASEMENT

The Grantors, NORMAN RISJORD and SYLVIA RISJORD, husband and wife, of Stevenson, Washington, for and in consideration of the sum of Ten Dollars and other valuable considerations, in hand paid, hereby grant, bargain, sell and convey to BAXCO CORPORATION, a corporation organized and existing under the laws of the State of Oregon, its successors and assigns, an easement over the existing private logging road as now constructed and established on the following described real property in Skamania County, Washington:

The southeast quarter of the northeast quarter (SE $\frac{1}{4}$  NE $\frac{1}{4}$ ), and the east half of the southeast quarter (E $\frac{1}{2}$  SE $\frac{1}{4}$ ) of Section 23, and the northwest quarter of the southwest quarter (NW $\frac{1}{4}$  SW $\frac{1}{4}$ ) of Section 24, Township 3 North, Range 7 E.W.M.;

Said easement to be limited in its use by the grantee, its successors and assigns, for the purpose of hauling timber, logs and forest products from the following described real property in Skamania County, Washington:

The northeast quarter of the northwest quarter (NE $\frac{1}{4}$  NW $\frac{1}{4}$ ), the west half of the northeast quarter (W $\frac{1}{2}$  NE $\frac{1}{4}$ ), and the northwest quarter of the southeast quarter (NW $\frac{1}{4}$  SE $\frac{1}{4}$ ) all in Section 23, Township 3 North, Range 7 E.W.M.

The aforesaid easement is expressly limited and shall automatically terminate on May 1, 1958.

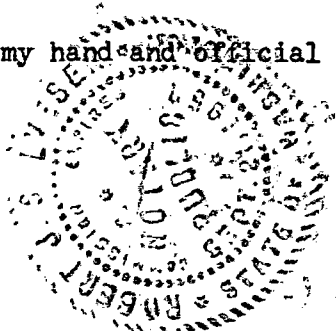
