mortgage to BANK OF STEVENSON, a corporation,

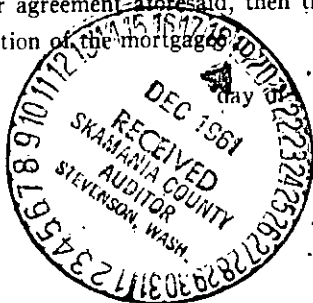
to secure payment of the sum of ONE THOUSAND THREE HUNDRED TWENTY and 84/100 - - - - -

 thence north 86° east a distance of 230.6 feet to intersection with the
