TRACT "A": The SW $\frac{1}{4}$  of Section 9, Twp. 1 North, Range 5 E. W. M., and the SE $\frac{1}{4}$  of the SE $\frac{1}{4}$  of Section 8 Twp., 1 N. Range 5 E. W. M., excepting the following:

- (1) Ten acres off—the east end of the No of the SW of See. 9 aforesaid;
- One acre, commencing at the NW corner of the SW said Sec. 9 thence south 2 rods to north line of Cape Horn and Mt. Zion Road, thence along the northerly line of said road to the NE corner of the NW of Sec. 3; thence west to the place of beginning;
- (3) Thirty Acres, more or less conveyed to Henry J. Biddle by deed recorded at page 227 Book "N" of Deeds, records of Skamania County, and easement for road described in said deed;
- (4) Spring and easement described in deed to Fred and Alfred Cocher recorded at page 326 Book "I" of Deeds records of Skamania County;

TRACT "B": Beginning at a point 40 rods South of the Northwest corner of Section 9, Township 1 North, Range 5, East of the Willamette Meridian, and running thence south 122 rods, more or less, to the North line of the old Cape-Horn-Mount Zion Road; thence north-easterly and following the North line of said road to a point on the south line of the Northwest Quarter of said section; thence East on said South line to the Southeast corner of said Northwest Quarter, thence north along the East line of said Northwest Quarter, 120 rods, more or less, to the Southeast corner of the North Half of the Northeast Quarter of the Northwest Quarter of said Section 9, thence West to a point that is 40 rods South of the Northeast corner of NW4 of the Northwest Quarter of said section, thence West 80 rods, more or less, to the place of beginning.
