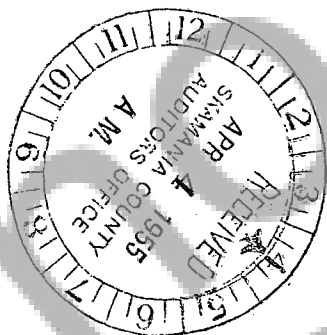
The grantor RAY LARSON and ELIZABETH K. LARSON, husband and wife,

the following described real estate, situate in the county of Skamania state of Washington:

That portion of the southeast quarter of the southeast quarter of the northeast quarter (SE $\frac{1}{4}$ SE $\frac{1}{4}$ NE $\frac{1}{4}$) of Section 27, Township 4 North, Range 7 E.W.M. more particularly described as follows:

Beginning at the quarter corner on the east line of the said Section 27, thence west along the south line of the northeast quarter (NE $\frac{1}{4}$) of the said Section 27 a distance of 200 feet, thence north 220 feet to the initial point of the tract hereby described; thence north 100 feet; thence east 200 feet to the east line of the said Section 27; thence south along the east line of the said Section 27 a distance of 100 feet; thence west 200 feet to the initial point;
