RASEMENT DEED

know all Men By These presents, that J. W. Kelley and Delima Kelley, busband and wife, hereinafter called the "Grantor", do hereby grant and convey to the United States of America, acting by and through the Forest Service; U.S.D.A., and assigns, hereinafter called the "Government", an easement and right-of-way, including the right, privilege and authority to locate, construct, maintain, patrol and repair a readway and electric and telephone transmission lines over, upon, along and across the following-described real property situated in the County of Skamania, State of Washington, to-wit:

A strip of land variable feet in width traversing the following-described real property:

SEZ SWZ of Section 22, T. 3 No. R. 8 E., W.M.

The said strip being of varying feet in width on each side of a center line of a road as located and to be constructed on the ground, with as much additional width as required for adequate protection of cuts and fills, said center line being more particularly described as follows:

Beginning at Engineer's Center line Station 72+73, which station is approximately 706.0 feet North and 1135.9 feet East of Witness Cerner Meander Corner on the east bank of Wind River common to Sections 22 and 27, T. 3 N., R. 8 E., W.M.; thence N. 86° 22' E. distance 107.92 feet to P.C. 73+80:92; thence along the arc of a 16° curve left, central angle 49° 15', distance 307.81 feet to P.T. 76+88.73; thence N. 37° 07' E., distance 355.19 feet to P.C. 8043:92; thence along the arc of a 16° curve left, central angle 29°23', distance 183.65 feet to P.T. 82+27.57; thence N. 7° 44' E., distance 37.43 feet to Station 82+65 which station interesects the north boundary of the said SE2 5W2 of said Section 22:

The parcel of land to which this description applies contains 2:88 acres, more or less:

A right-of-way plat showing the location of said right-of-way is attached as Exhibit "A" to this easement deed and hereby made a part hereof:

Together with reasonable rights of ingress, egress and regress to and from said lands for the purposes designated.

The rights, privileges and authorities herein granted are for full use and enjoyment by the Government for any and all purposes deemed necessary or desirable in connection with the control, management and administration of the national forest, or the resources thereof, and, insofar as compatible therewith, use by the general public and the rights,

privileges and authorities herein granted shall continue as long as used for the purposes granted but if for a period of five years the Government shall cease to use the rights, privileges and authorities for the purposes granted or shall abandon the use of the easement herein granted then, in any such events, the Grantor may terminate this easement and all rights hereunder shall revert to the holder of the fee title to the lands.




