TO HAVE AND TO HOLD said timber unto said grantce, his heirs and issigns, subject to the following terms and conditions:

- 1. Grantom covenant and warrants that they are the owners of the hereinbefore described timber; that they have the right to sell the same, and that said timber is free and clear of all liens and encumbrances. Grantors further covenant to defend said title to the grantee, its heirs, and assigns, against the lawful claims and demands of any person whomsoever. Granters further covenant to execute such applications for timber cutting permits as shall be required for the cutting and removal of the same.
- 2. Grantee is hereby accorded the right to construct and maintain such logging roads on the aforesaid tract as shall be required to effect the removal of said timber. Grantee is further accorded the right to install a saw mill upon the aforesaid tract for the purpose of manufacturing the timber herein sold.
- Grantors covenant to fall the unmerchantable snags on said tract as shall be required by the forest warden.
- 4. All rights herein granted shall expire four (4) years after date, whereupon all rights in said timber shall revert to the granters.
