At the option of the Company, such payments may be made either in legal tender money of the United States, or in bonds issued under the Indenture at their principal amount or partly in cash and partly in bonds.

Section 4. The Company covenants and agrees that all of the provisions contained in Sections 4 through 8 inclusive of Article II of said Supplemental Indenture, dated November 1, 1941, as said Sections and the Indenture are amended by Section 1 of Article III of said Supplemental Indenture dated March 1, 1948 and by Sections 1 and 2 of Article III of said Supplemental Indenture dated November 1, 1950, shall be, and shall continue to be, applicable to the bonds of the 4%% Series due 1990 except as hereinafter otherwise provided, until the payment or redemption of all bonds of the 4%% Series due 1990.

Section 5. If within one hundred twenty (120) days after the deposit of cash in the Sinking Fund provided for in Section 1 of Article If of any or all of the respective Supplemental Indentures dated November 1, 1941, March 1, 1948, November 1, 1950, May 1, 1951, May 1952, November 1, 1954, November 1, 1955, May 1, 1957, May 1, 1958, May 1, 1960, May 1, 1961, and/or provided for in Section 1 of Article 11 of this Supplemental Indenture, said cash, or any part thereof exceeding \$10,000, shall not have been so used by the Corporate Trustee for the purchase of bonds, the Corporate Trustee shall notify the Company in writing of the amount of eash so held, and the Company hereby covenants and agrees that if it then be not in default, as defined in Section Lof Article VI of the Indenture, promptly to redeem, in the manne provided in Article V of the Indenture, such number of bonds as will. as nearly as may be, exhaust the money so hold in the Sinking Fund, and pending such redemption, no further bonds shall be purchased by the Corporate Trustee from such moneys. Notwithstanding any other provisions in the Indenture, the redemption price of any bonds redecined pursuant to the provisions of this Article shall be the face amount of such bonds, together with accrued interest thereon, and the premium, if any, as provided for in the form of such bonds for the redemption of bonds from funds in the Sinking Fund. The Company agrees to deposit with the Corporate Trustee such sums as may be necessary to pay the accrued interest, if any, on any bonds purchased or redeemed pursuant to this Article.
