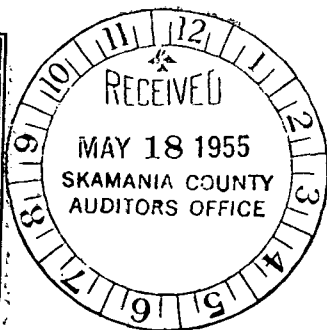
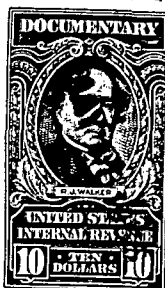


WARRANTY DEED

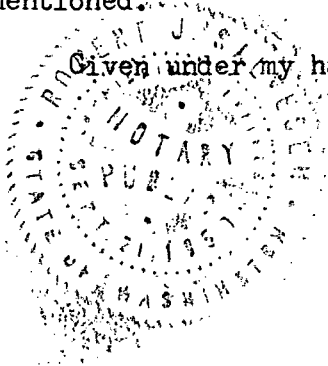

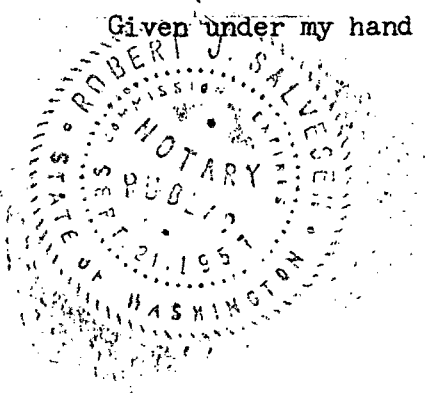
