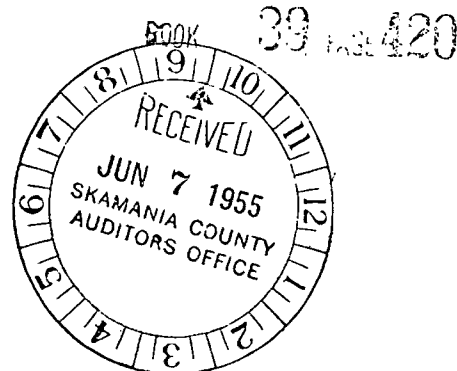

NE $\frac{1}{4}$ of the NE $\frac{1}{4}$ of Section 22, Township 3 North, Range 7 East, W. M.

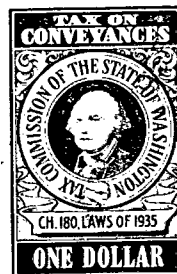
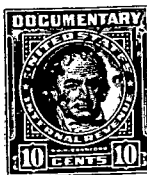
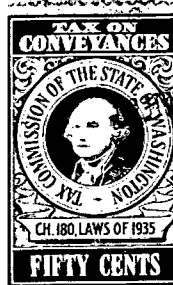
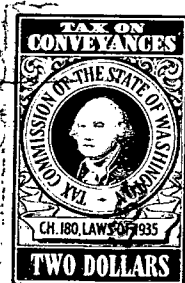
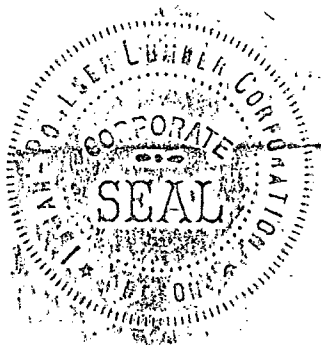
