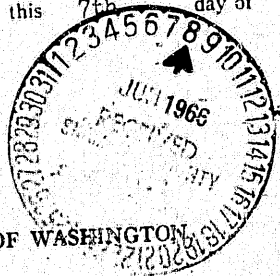

in the County of Skamania and State of Washington, to-wit:A two inch domestic water line consisting of approximately 640 feet of two inch pipe
and related appurtenances as now constructed on the existing county road right-of-way
in the East 1/2 of Section 21, R 3 N, Twp 10 E.W.M.The seller reserves the right of reimbursement from future owners obtaining water
service through this line; i.e., 50% from one new water connect, or 33-1/3% from
two water connects, etc. This reimbursement clause shall be null and void with
the sale of the property which now receives water service from said water line.
