SUMMARY OF LEASED PROPERTY

WITNESSETH:

WHEREAS, by Lease dated March 1, 1956, HEGEWALD LUMBER COMPANY, a Washington corporation, Stevenson, Washington, Lessee, leased certain real property in Skamania County, Washington, from THOMAS O. MONAGHAN and PATRICIA MONAGHAN, husband and wife, and ROY D. ZEIGLER and MARGARET ZEIGLER, husband and wife, Lessors; and

WHEREAS, said leased real property includes a certain strip of land 50 feet in width and 300 feet in length upon which Crown Zellerbach Corporation desires to construct and operate a truck scales for the weighing of logs and logging trucks; and

WHEREAS, in order that said Crown Zellerbach Corporation might construct and operate such truck scales on said land, it is desirable that it lease said strip of land from the owners thereof; and

WHEREAS, the abovesaid HEGEWALD LUMBER COMPANY agreed to surrender such strip of land to the said Lessors so as to enable them to let and lease the same to Crown Zellerbach Corporation.

NOW THEREFORE, in consideration of One (\$1.00) Dollar and other good and valuable consideration to it paid by the said Lessors, HEGEWALD LUMBER COMPANY hereby surrenders all its right and interest in the following real property to said THOMAS O. A strip of land 50 feet in width located in the NW $\frac{1}{4}$  SW $\frac{1}{4}$  of Section 27, Township 3 North, Range 8 East, W.M., Skamania County, Washington, measured perpendicular to the easterly right-of-way boundary of the Smith Log Dump county road in said NW $\frac{1}{4}$  SW $\frac{1}{4}$ . Said 50-foot strip beginning at the north boundary line of said NW $\frac{1}{4}$  SW $\frac{1}{4}$  and running thence southerly parallel with the said easterly right-of-way boundary line a distance of 200 feet, more or less, as shown on attached sketch marked "Exhibit A", and by this reference made a part hereof.

Except as hereby modified, the said Lease dated March 1, 1956, shall be and remain in full force and effect for the term thereof.


