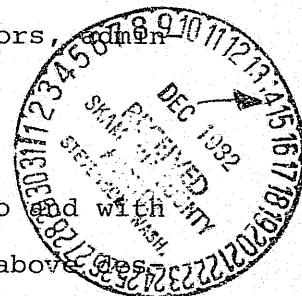


BILL OF SALE
