

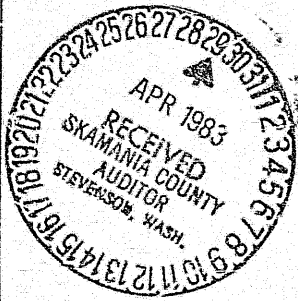


KNOW ALL MEN BY THESE PRESENTS, That LADD J. and SHARON R. ZIEGLER
