

BILL OF SALE

STEVENS-CARSON SCHOOL DISTRICT 303, Seller, in consideration of the sum of Thirteen Thousand Dollars (\$13,000.00), receipt of which is hereby acknowledged, does hereby sell, assign, transfer and set over to PACIFICORP, a Maine corporation, doing business as PACIFIC POWER & LIGHT COMPANY, all of its interest in and to the personal property and improvements, including, but not limited to, the 40' x 90' school building and the 1400 sq. ft. residence located on the following described property:

Parcel 1. That part of Lot 5 of said Section 26, bounded and described as follows:

Beginning at a point where the north and south centerline of said Section 26 intersects Pacific's Swift Project Boundary Line, which point is marked by an iron pipe;
thence North 0° 11' 10" West 420.0 feet along said centerline of said Section;
thence North 89° 48' 50" East 118.0 feet, more or less, to a point on said project boundary line;
thence southerly and westerly along said project boundary line to the point of beginning.

Parcel 2. That part of Lot 2 and the Northwest Quarter (NW1/4) of the Northeast Quarter (NE1/4) of Section 26, Township 7 North, Range 6 East, Willamette Meridian, bounded and described as follows:

Beginning at a point where the centerline of the existing Lewis River Road intersects the north and south centerline of said Section 26;
thence North 0° 11' 10" West 950 feet along said centerline of said Section 26;
thence southeasterly on a line at right angle to said Lewis River Road to the centerline thereof;
thence southwesterly along the centerline of said Lewis River Road to the point of beginning; EXCEPTING therefrom the right of way of said Lewis River Road.

Parcel 3. That part of Lot 2 and the Northwest Quarter (NW1/4) of the North-east Quarter (NE1/4) of Section 26, Township 7 North, Range 6 East, Willamette Meridian, bounded and described as follows:

Beginning at a point on the centerline of said Section 26, North 0°11' 10" West 950 feet from the centerline of the existing Lewis River Road;
thence continuing North 0° 11' 10" West 950 feet along the centerline of said Section 26 to a point;
thence southeasterly on a line at right angle to the centerline of said Lewis River Road;
thence southwesterly along the centerline of said Lewis River Road 775 feet, more or less, to a point which is on a line, measured at right angle from the centerline of said Lewis River Road, intersecting the aforesaid point of beginning;
thence northwesterly along said line to the point of beginning, EXCEPTING therefrom the right of way of the Lewis River Road.

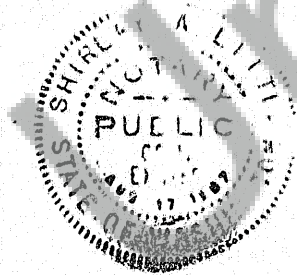
