A four inch domestic water line consisting of approximately 1400 feet of four inch plastic pipe and related appurtenances as now constructed on the existing County Road number 2381, Dillingham Road, as recorded in Book 59 at page 390 of Deeds, Records of Skamania County.

TOGETHER with a four inch domestic water line and related appurtenances extending Northerly from above said four inch water line approximately 500 feet, installed upon the Right of Way Easement granted to the party of the second part as recorded in Book 62 at page 346 of Deeds, Records of Skamania County
