- 1. The District will construct, operate and maintain a Line Extension extension to serve the Owner's premises, described as follows, to wit:

- 2. The Owner acrees to purchase Electricity from the District for a scried of 8 years, commencing with the billing date during which such Electric Service shall be available, and further agrees to pay minimum billing during such period, of not less than \$10.20 per each bi-monthly billing therein, irrespective of whether the service is used or not.
- 3. It is further agreed that this contract shell be a continuing lien, upon the above described property against the Owner, his beins or assigns in interest until such time as the Fillings in the above mentioned amount representing the cost of the extension have been collected in full.
- 4. In the event that the cost of such construction is less than the estimate thereof, the District will, after the completion thereof, make such adjustment in the amount of minimum b.-monthly billings or the number of them as is justified by the circumstances.

Costs involved in recording such resolution shall be borne by the party seeking the change.
- 7. Foreclosure under this lien shall be in accordance with the regularly prescribed procedure for the foreclosure of Real Estate Mortgages in the State of Washington, and all costs involved including a reasonable Attorney's fee shall be horne by the owner, his heirs and assigns.
- 8. It is agreed that the title of said lines shall remain with the District its successors, or assigns.
