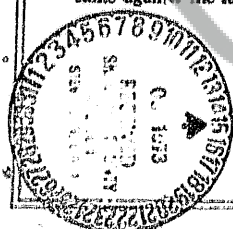
One frame cabin located on said Lot 5, Lot leased from the **Water Front Ret., Inc.**, to be sold as is, free and clear of encumbrances.

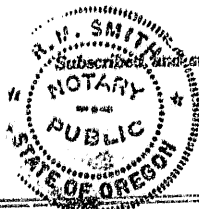
