

Forthwith after the March 15 next preceding any April Sinking Fund payment date or the September 15 next preceding any October Sinking Fund payment date on which the Company will be required to make to the Corporate Trustee a payment in cash for the Sinking Fund, the Corporate Trustee shall proceed to select for redemption, in the manner provided in Article Five of the Mortgage, a principal amount of bonds of the 1982 Series equal to the amount of such cash payment, and, in the name of the Company, shall give notice, as required by the provisions of Section 3 of this Article Two and Article Five of the Mortgage, of the redemption for the Sinking Fund of the bonds so selected on the then next ensuing interest payment date. The Company shall pay to the Corporate Trustee at least one day before such next ensuing interest payment date the sum required to redeem the bonds so called, including interest to the redemption date, which sum shall be applied by the Corporate Trustee to the redemption of such bonds. Any moneys paid to the Corporate Trustee in respect of the Sinking Fund payment due October 31, 1982 shall be applied to the payment of the bonds of the 1982 Series at their maturity.

The Company shall not be entitled to redeem for the Sinking Fund at the sinking fund redemption price on any interest payment date a principal amount of bonds of the 1982 Series greater than the amount required to be redeemed for the Sinking Fund on that date by the provisions of Paragraphs A and B of this Section.

SECTION 5. The Company covenants that, so long as any bonds of the 1982 Series are outstanding, it will file with the Corporate Trustee, on or before June 15 in each year beginning in the year 1964 and continuing to and including the year 1981, a Certificate of Available Gas Supply, dated not earlier than the May 1 next preceding such June 15, stating that, in the opinion of the signer or signers of such Certificate, the date of exhaustion of the Company's available gas supply will be a date not earlier than November 1, 1982 or will be a specified date prior to November 1, 1982. The term "date of exhaustion of the Company's available gas supply", as used herein, shall mean the date on which, in the opinion of the signer or signers of such Certificate, the Company's available gas supply (as hereinafter in this Section defined),
