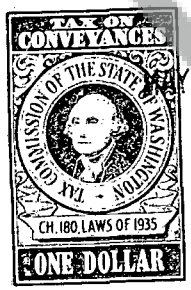
THE GRANTOR ESSIE M. HENDRICKS JONES, and F. H. JONES, her husband,

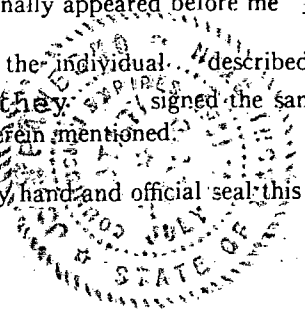
