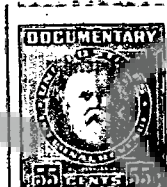

 the following described real estate, situate in the county of Skamania state of Washington:

A tract of land in the Jos. Robbins D. L. C. in Section 27, Township 3
 North, Range 8 E.W.M., described as follows:

Beginning at a point marked by an iron pipe 660 feet east and 682 feet
 north of the intersection of the south line of the said Section 27 with
 the west line of the said Jos. Robbins D. L. C.; thence east 169.4 feet;
 thence north 03° 23' east 85.5 feet; thence west 61.4 feet to the center
 of a certain unnamed creek; thence in a northwesterly direction along the
 center of said creek to a point 60 feet north, and perpendicular to the
 westerly extension, of the last described course; thence west 93 feet,

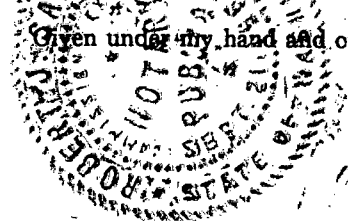
