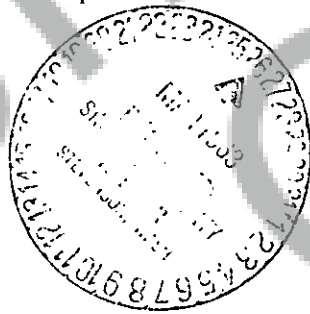
KNOW ALL MEN BY THESE PRESENTS, That **BANK OF STEVENSON, a corporation,**
