Commencing at a point 25.65 rods west and 62.36 rods north of the southeast corner of Government Lot 1 of Section 36, Township 3 North, Range 7 E.W.M.; thence west 25.65 rods to intersection with the east line of the Lillegard tract; thence south 31.18 rods along the east line of the said Lillegard tract; thence east 25.65 rods more or less to a point due south of the point of beginning; thence north 31.18 rods to the point of beginning; containing 5 acres, more or less; EXCEPT right of way for county road known as Johns Road along the west line of the above described tract.

and said first parties convey and warrant said described premises to said second part subject to said contract and second part Y hereby assume and agree to fulfill the conditions of said real estate contract.

Said first parties hereby covenant that there is now unpaid on the principal of said contract the sum of ONE THOUSAND SEVEN HUNDRED SEVENTY ONE and No/100 (\$ 1771.00) and that the entire amount is payable according to the terms of the contract and there are no deductions or off-sets whatsoever.


