

REAL ESTATE CONTRACT

THIS CONTRACT, made this 22nd day of July, 1955 between
 Joseph O. Blouin and Betty B. Blouin, hereinafter called the "purchaser"
 husband and wife
 Ruth M. White, a widow hereinafter called the "seller,"

WITNESSETH: The seller agrees to sell to the purchaser, and the purchaser agrees to purchase of the

seller the following described real estate with the appurtenances, situate in Skamania County, Washington:

Beginning at a point 5 rods North of the Southwest corner of Section 16, Township 3 North, Range 8 E.W.M.; running thence East 29 rods, thence North 32 rods, thence West to the west line of Section 16; thence South to a point of beginning containing six (6) acres, more or less;

ALSO, all of the grantor's right and interest in and to a privilege for a road along a strip of land 30 feet wide, beginning at the Southwest corner of the above described land and extending South along the West line of Sections 16 and 21 to the County Road, and also the following described property:

~~Free of encumbrances except:~~

Beginning at a point 29 rods east and 37 rods North of the Southwest corner of Section 16, Township 3 North, Range 8 E.W.M.; running thence west to the west line of Section 16, Thence 17 rods in a northerly direction along the said west line of Section 16, thence in a straight line in a Southeasterly direction to point of beginning: containing about one and one-half (1½) acres more or less.

Together with all and single the tenements, hereditaments and appurtenances thereunto belonging. - Free of encumbrances except as described below.

On the following terms and conditions: The purchase price is Forty Eight Hundred and no/100 (\$ 4800.00) dollars, of which Five Hundred and no/100 (\$ 500.00) dollars

has been paid, the receipt whereof is hereby acknowledged, and the purchaser agrees to pay the balance of said purchase price as follows:

On or before July 18, 1955, \$500.00 will be paid. Beginning on or before September 1, 1955, monthly payments of not less than \$50.00 will be paid until the full purchase price has been paid plus interest at six per cent per annum. Interest is to be computed on unpaid balance at time of all payments and included in said payments. It is understood and agreed that the property is now encumbered with a mortgage in the amount of \$500 to J.C. Price and at the time of the \$500 payment above described, said mortgage will be discharged by seller in full and the release of same recorded. Should seller not arrange for discharge of said mortgage at time of \$500 payment, purchaser may instead pay the \$500 to J.C. Price and deduct from following monthly payment sufficient to pay interest and legal charges incurred in so doing.

No timber shall be removed from the property for sale during the terms of this contract without written permission of the seller.

The purchaser agrees: (1) to pay before delinquency all payments of whatsoever nature, required to be made upon or by virtue of said mortgage, if any; also all taxes and assessments which are above assumed by him, if any, and all which may, as between grantor and grantee, hereafter become a lien on the premises; and also all taxes which may hereafter be levied or imposed upon, or by reason of, this contract or the obligation thereby evidenced, or any part thereof; (2) to keep the buildings now and hereafter placed upon the premises unceasingly insured against loss or damage by fire, to the full insurable value thereof, in the name of the seller as owner, in an insurance company satisfactory to the seller for the benefit of the mortgagee, the seller, and the purchaser, as their interests may appear, until the purchase price is fully paid, and to deliver to seller the insurance policies, renewals, and premium receipts, except such as are required to be delivered to the mortgagee; (3) to keep the buildings and all other improvements upon the premises in good repair and not to permit waste; and (4) not to use the premises for any illegal purpose.

In the event that the purchaser shall fail to pay before delinquency any taxes or assessments or any payments required to be made on account of the mortgage, or to insure the premises as above provided, the seller may pay such taxes and assessments, make such payments, and effect such insurance, and the amounts paid therefor by him shall be deemed a part of the purchase price and become payable forthwith with interest at the rate of 10 per cent per annum until paid, without prejudice to other rights of seller by reason of such failure.

The purchaser agrees to assume all risk of damage to any improvements upon the premises, or of the taking of any part of the property for public use; that no such damage or taking shall constitute a failure of consideration, but in case of such damage or taking, all moneys received by the seller by reason thereof shall be applied as a payment on account of the purchase price of the property, less any sums of money which the seller may be required to expend in procuring such money, or at the election of the seller, to the rebuilding or restoration of such improvements.

The seller agrees, upon receiving full payment of the purchase price and interest in the manner above specified, to execute and deliver to purchaser a **Warranty** deed to the property, excepting such part thereof which may hereafter be condemned, if any, free of incumbrances except those above mentioned, and any that may accrue hereafter through any person other than the seller.

The seller has delivered, or within ten days herefrom will procure and deliver, to the purchaser, a title policy in usual form issued by the Puget Sound Title Insurance Company, insuring the purchaser to the full amount of said purchase price against loss or damage occasioned by reason of defect in, or incumbrance against, seller's title to the premises, not assumed by the purchaser, or as to which the conveyance hereunder is not to be subject.

The parties agree: (1) to execute all necessary instruments for the extension of payment or renewal of said mortgage during the period prior to the delivery of said deed, or the termination of purchaser's rights by virtue of the provisions hereof; provided the seller shall not be obligated thereby to assume any personal obligation or to execute any mortgage providing for a deficiency judgment against the seller, or securing a principal indebtedness in excess of that now unpaid on the above mentioned mortgage or bearing an interest rate of more than two per cent greater than that of the original mortgage indebtedness; (2) that the purchaser has made full inspection of the real estate and that no promise, agreement or representation respecting the condition of any building or improvement thereon, or relating to the alteration or repair thereof, or the placing of additional improvements thereon, shall be binding unless the promise, agreement or representation be in writing and made a part of this contract; (3) that the purchaser shall have possession of the real estate on

August 1, 1955 and be entitled to retain possession so long as purchaser is not in default in carrying out the terms hereof; and (4) that, upon default, forfeiture may be declared by notice sent by registered mail to the address of the purchaser, or his assigns, last known to the seller.

Time is of the essence hereof, and in the event the purchaser shall fail to comply with or perform any condition or agreement hereof promptly at the time and in the manner herein required, the seller may elect to declare all of the purchaser's rights hereunder terminated, and upon his doing so, all payments made by the purchaser hereunder and all improvements placed upon the premises shall be forfeited to the seller as liquidated damages, and the seller shall have the right to re-enter and take possession of the property; and if the seller within six months after such forfeiture shall commence an action to procure an adjudication of the termination of the purchaser's rights hereunder, the purchaser agrees to pay the expense of searching the title for the purpose of such action, together with all costs and a reasonable attorney's fee.

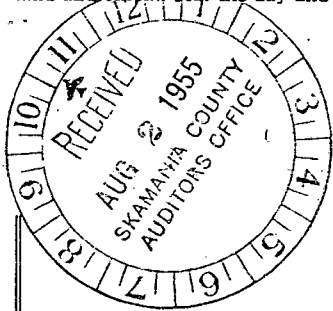
