For value received the undersigned Grantors, Harold W. McNeel and Mattie A. McNeel, husband and wife do hereby grant to PACIFIC POWER & LIGHT COMPANY, a corporation, its successors and assigns, the Grantee, an easement or right of way for an electric transmission and distribution line of one or more wires and all necessary or desirable appurtenances (including telephone and telegraph wires, towers, poles, props, guys and other supports and the right to place all or any part of such line in underground conduits) at or near the location and along the general course now located and staked out by the Grantee over, across and upon the following described real property in Skamania County, State of Washington to-wit:

The West 1600 feet of the James M. Findley D.L.C. #39, except the West 10 chains (660 feet) thereof lying North of the right-of-way line of State Highway #8 and North of the quarry site of the State of Washington as described in Book 27 page 47, Deed Records, Skamania County, all in Section 36, Township 3 North, Range 8 East, W.M.

Center line of said power line to be located approx. 75 feet Northeastly of and parallel to the North line of said quarry site, extending Southeastly to intersect existing transmission line.

Together with the right of ingress and egress over the adjacent lands of the Grantors for the purpose of constructing, reconstructing, stringing new wires on, maintaining and removing such line and appurtenances, and exercising other rights hereby granted.

All such rights hereunder shall cease if and when such line shall have been abandoned.

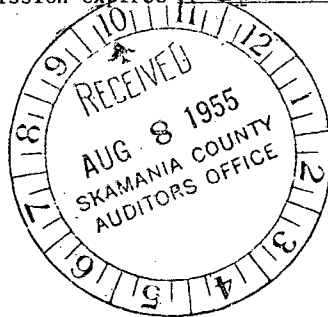
