

WARRANTY DEED

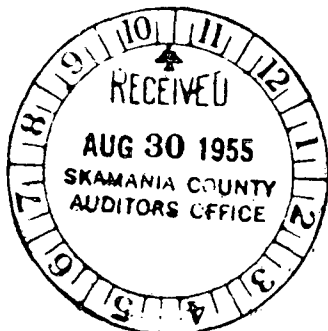
The grantors R. M. HEGEWALD and HELEN B. HEGEWALD, husband and wife, of the Town of Stevenson, County of Skamania, State of Washington, for and in the consideration of Ten and No/100 (\$10.00) Dollars, and other valuable considerations, in hand paid, convey and warrant to J. R. REHAL and HAZEL M. REHAL, husband and wife, the following described real estate, situate in the County of Skamania, State of Washington:

The North Half of the Southwest Quarter of the Southwest Quarter (N $\frac{1}{2}$ SW $\frac{1}{4}$ SW $\frac{1}{4}$) and the Southeast Quarter of the Southwest Quarter of the Southwest Quarter (SE $\frac{1}{4}$ SW $\frac{1}{4}$ SW $\frac{1}{4}$) of Section 36, Township 3 North, Range 7 E.W.M.; EXCEPT a tract of land conveyed to William Goepel and wife by deed dated November 25, 1914, and recorded at page 159 of Book P of Deeds, Records of Skamania County, Washington;

Beginning at a point 300 feet west of the southwest corner of Government Lot 7 of Section 1, Township 2 North, Range 7 E.W.M., thence north to northerly right of way line of county road formerly designated as State Highway No. 8 and the initial point of the tract hereby described; thence north to intersection with north line of said Section 1; thence east along the north line of said Section 1 to the center of Rock Creek; thence southerly along the center of Rock Creek to intersection with north line of said county road formerly designated as State Highway No. 8; thence following the northerly right of way line of said road south 63° 24' west to the initial point; EXCEPT a tract of land conveyed to J. R. Rehal and Hazel M. Rehal, husband and wife, by deed dated October 31, 1951, and recorded November 7, 1951, at page 75 of Book 34 of Deeds.

This conveyance is a correction deed and is given for the purpose of confirming title in the grantees and more particularly to correct the description of the real property set forth in that certain deed dated August 12, 1955, and recorded August 12, 1955, at page 52 of Book 40 of Deeds, Records of Skamania County, Washington.

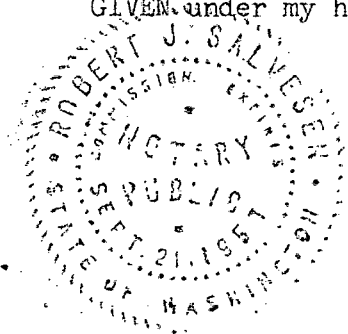


