hereinafter referred to as Grantors, (whether one or more), do hereby grant and convey unto PACIFIC NORTHWEST PIPELINE CORPORATION, a Delaware corporation, its successors and assigns, hereinafter referred to as Grantee, the right to select the route for and construct, maintain, inspect, operate, protect, repair, replace, alter or remove a pipeline or pipelines for the transportation of oil, gas and the products thereof, on, over and through the following described lands, which Grantors warrant that they are the owners in fee simple, situated in the County of

Skamania; State of Washington, to-wit:

That portion of the Northwest Quarter (NW $\frac{1}{4}$) of Section 34, Township 2 North, Range 6 E.W.M., lying Northerly of the Northerly line of the easement granted to the United States of America for the Bonneville Power Administration's Bonneville-Vancouver electric power transmission line; EXCEPT access road easement to said power line; and EXCEPT water rights on Duncan Creek, including the rights acquired by the S. P. & S. Railway Company to maintain a dam and water pipeline.

The Right Of Way herein granted shall be 75' in width for construction purposes and shall revert to a width of 50' after construction.

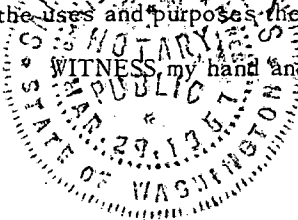
