the following described real estate, situate in the county of Skamania state of Washington:

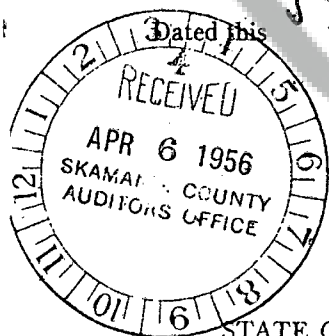
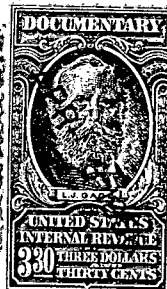

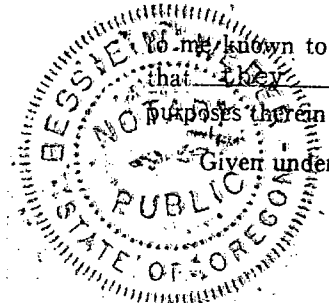
