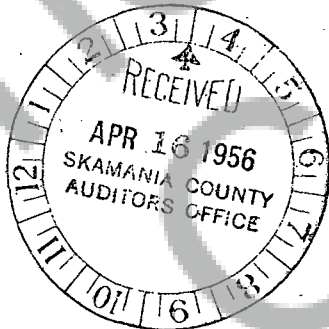
RATIFICATION AGREEMENT

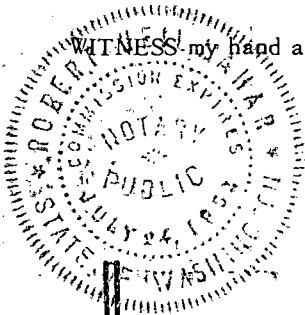
