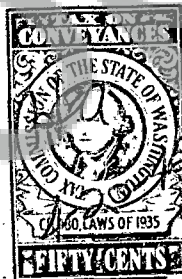
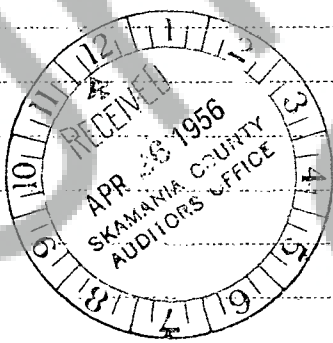
THIS INDENTURE, made this 20th day of April, 1945, between
