THIS INDENTURE, Made this 26th day of April, 1956

Reid Sheriff of the County of Skamania, State of Washington, and party of the first part hereto, by virtue of the said sale, under said special execution, and in pursuance of the statute in such cases made and provided, and for and in consideration of the said sum of Two Thousand Four Hundred Ninety-four and 69/100 ----- Dollars, lawful money of the United States of America so bid and paid as aforesaid, the receipt whereof is hereby acknowledged, has granted, bargained, sold, conveyed and confirmed, and by these presents does grant, bargain, sell, convey and confirm unto the said party Y of the second part and to its successors ~~heirs~~ and assigns forever, the property in said special execution mentioned, situate in the County of Skamania, State of Washington, and described as follows, to-wit:

The East Half of the Southeast Quarter of the Southeast Quarter ($E\frac{1}{2} SE\frac{1}{4} SE\frac{1}{4}$), and the Southwest Quarter of the Southeast Quarter of the Southeast Quarter ($SW\frac{1}{4} SE\frac{1}{4} SE\frac{1}{4}$), Section 26, Township 3 North, Range 7 E.W.M.;

EXCEPT the following described tract: Commencing at the southwest corner of the Southwest Quarter of the Southeast Quarter ($SW\frac{1}{4} SE\frac{1}{4}$) of said Section 26; thence north 400 feet; thence east 200 feet; thence south 400 feet; thence west 200 feet to the place of beginning.

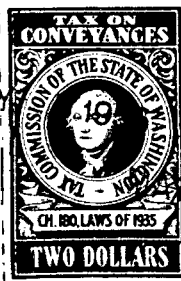
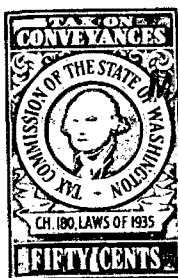
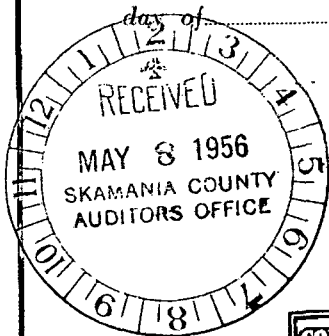
