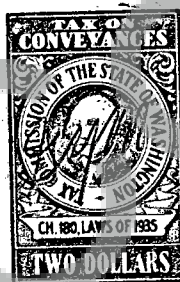
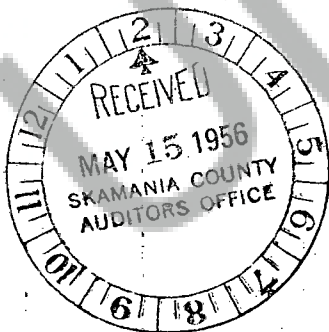
THE GRANTOR S., Vernon S. Campbell and Frances E. Campbell, husband and wife,
