For and in consideration of the sum of Ten (\$10.00) Dollars cash, the receipt of which is hereby acknowledged and in addition thereto, an aggregate sum equal to One (\$1.00) Dollar per lineal rod of pipeline constructed under the
terms hereof, to be paid at the time and in the manner hereinafter set forth,
whose address is Route 1, Stevenson, Washington
hereinafter referred to as Grantors, (whether one or more), do hereby grant and convey unto PACIFIC NORTHWES PIPELINE CORPORATION, a Delaware corporation, its successors and assigns, hereinafter referred to as Granted the right to select the route for and construct, maintain, inspect, operate, protect, repair, replace, alter or remove pipeline or pipelines for the transportation of oil, gas and the products thereof, on, over and through the following described lands, which Grantors warrant that they are the owners in fee simple, situated in the County of
Skamania; State ofWashington, to-wit:
That portion of Government Lot 9 of Section 36, Township 3 North, Range $7\frac{1}{2}$ E.W.M., described as follows: Beginning at the intersection of the north line of the Henry Shepard D. L. C. with the Second Guide Meridian E.W.M.; thence north 418 feet; thence east 206 feet; thence southwesterly to a point on the north line of the said D. L. C. 169 feet east of the point of beginning; thence west 169 feet to the point of beginning EXCEPT right of way for county road known as Strawberry Road; ALSO: Beginning at the Southeast corner of Government Lot 1 of Section 36, Township 3 North, Range 7 E.W.M.; thence north 62.36 rods to the northeast corner of the said Government Lot 1; thence west 25.65 rods; thence south 62.36 rods to the south line of the said Government Lot 1; thence east 25.65 rods to the point of beginning Section 36, Township 3 North, Range 7 E.W.M., and Section 36, Township 3 North, Range 7 E.W.M., and 7 E.W.M., together with the right of in gress and egress to and from said line or lines, or any of them, for the purposes aforesaid; hereby releasing an waiving, as to Grantee, all rights under and by virtue of the homestead exemption laws of said state.
Grantee agrees that after it has completed its survey of the route for its pipeline and has established the route thereof and before pipeline construction is commenced, it will pay Grantors, in proportion to Grantors' respective interests, a total sum equivalent to One (\$1.00) Dollar per lineal rod of pipeline so surveyed and established.
Grantors shall have the right to use and enjoy the above described premises, except as to the rights hereing granted; and Grantors agree not to build, create or construct or to permit to be built, created or constructed any obstruction, building, engineering works, or other structures over or that would interfere with said pipeline or lines of Grantee's rights hereunder. Grantee hereby agrees to pay any damages which may arise to growing crops, pasturage timber, fences or buildings of said Grantors from the exercise of the rights herein granted; said damages, if not mutually agreed upon, shall be ascertained and determined by three disinterested persons, one to be appointed by the undersigned Grantors, their successors, heirs or assigns, one to be appointed by the Grantee, its successors or as signs, and the third by the two so appointed, and the written award of such three persons shall be final and conclusive
Should more than one pipeline be laid under this grant, at any time, an additional consideration, calculated o the same basis per lineal rod as specified above, shall be paid for each such line laid.
It is agreed that the obligation of Grantee to make any payment hereunder shall be satisfied by delivery of sucpayment to any of the Grantors for the benefit of all Grantors.
Any pipeline constructed by Grantee across lands under cultivation shall, at the time of construction thereof, b buried to such depth as will not interfere with such cultivation.
The Grantee shall have the right to assign this grant in whole or in part.
It is agreed that this grant covers all the agreements between the parties hereto and that no representations of statements, verbal or written, have been made, modifying or adding to or changing the terms of this agreement.
The interest of the Grantee in the property covered hereby is to be held by the Grantee subject to the lien of an in accordance with the provisions of the Mortgage and Deed of Trust dated as of October 1, 1955, from Pacific North west Pipeline Corporation to J. P. Morgan & Co., Inc., and Robert P. Howe, as Trustees.
The terms, conditions and provisions of this contract shall extend to and be binding upon the heirs, executors administrators, personal representatives, successors and assigns of the parties hereto.
TO HAVE AND TO HOLD said right-of-way and easement unto said Grantee, its successors and assigns unt such first pipeline be constructed and so long thereafter as a pipeline is maintained thereon.
