## REAL ESTATE CONTRACT

THIS CONTRACT, made this 1st

September, 1956

Mae S. Wedrick, a single woman

hereinafter called the "seller" and

Forrest R. Robbins and Bertha L. Robbins, husband and wife

hereinafter called the "purchaser,"

WITNESSETH: The seller agrees to sell to the purchaser, and the purchaser agrees to purchase of the

Skamania seller the following described real estate with the appurtenances, situate in County,

Commencing at a point ten chains East, thence 682 feet North and therce 418 feet East of the intersection of the West boundary of Joseph Polying Donation Land Claim with the South boundary of Section 27, Township 5 North, Range 8 E.W.M., being the point of beginning, running from this point thence North 209 feet; thence West 154 feet; thence North 429 feet; thence East 596 feet; thence South 638 feet and thence West 242 feet to the point


of beginning, containing five acres, more or less.

ALSO, Easement for right-of-way from the southwest corner of the above described tract the center line of which is described as follows: Commencing at a point six feet East of the initial point of the tract above described, Free of insumbrances, except: thence South six feet; thence West 394 feet; thence Northwesterly to a point 10 chains East and 752 feet North of the intersection of the West boundary of the Joseph Robbins Donation Land Claim with the South boundary of Section 27 aforesaid; thence West to intersection with Secondary Highway known as the Berge Road, the said right of way to be six feet in width on each side of the said center line from the initial six feet in width on each side of the said center line from the initial point to commencement of the last, westerly course and from thence ten feet in width on each side of said center line to intersection with said Berge Road. ALSO all water rights appurtenant thereto.

On the following terms and conditions: The purchase price is Seven Thousand and no/100 ---7000,00 ) dollars, of which One Thousand and no/100 -----(\$ 1000,00 ) dollars

has been paid, the receipt whereof is hereby acknowledged, and the purchaser agrees to pay the balance of said purchase price as follows:

Beginning on or before extober /, 1956, monthly payments of not less than \$60.00 will be made until Thirty Five Hundred dollars (\$3500.00) has been paid on the principal, then the balance of purchase price plus interest will be paid in cash. Interest is to be computed at the rate of six per cent per annum, computed on unpaid balance at times of payment and included in payments. Balance of contract plus interest may be paid in full at any time purchaser is not in default under this contract. No standing timber may be cut without written under this contract. No standing timber may be cut without written consent of the seller.

The purchaser agrees: (1) to pay before delinquency all payments of whatsoever nature, required to be made upon or by virtue of said mortgage, if any; also all taxes and assessments which are above assumed by him, if any, and all which may, as between grantor and grantee, hereafter become a lien on the premises; and also all taxes which may hereafter be levied or imposed upon, or by reason of, this contract or the obligation thereby evidenced, or any part thereof; (2) to keep the buildings now and hereafter placed upon the premises unceasingly insured against loss or damage by fire, to the full insurable value thereof, in the name of the seller as owner, in an insurance company satisfactory to the seller for the benefit of the mortgagee, the seller, and the purchaser, as their interests may appear, until the purchase price is fully paid, and to deliver to seller the insurance policies, renewals, and premium receipts, except such as are required to be delivered to the mortgagee; (3) to keep the buildings and all other improvements upon the premises in good repair and not to permit waste; and (4) not to use the premises for any illegal purpose.

In the event that the purchaser shall fail to pay before delinquency any taxes or assessments or any payments required to be made on account of the mortgage, or to insure the premises as above provided, the seller may pay such taxes and assessments, make such payments, and effect such insurance, and the amounts paid therefor by him shall be deemed a part of the purchase price and become payable forthwith with interest at the rate of 10 per cent per annum until paid, without prejudice to other rights of seller by reason of such failure.

The purchaser agrees to assume all risk of damage to any improvements upon the premises, or of the taking of any part of the property for public use; that no such damage or taking shall constitute a failure of consideration, but in case of such damage or taking, all moneys received by the seller by reason thereof shall be applied as a payment on account of the purchase price of the property, less any sums of money which the seller may be required to expend in procuring such money, or at the election of the seller, to the rebuilding or restoration of such improvements.

The seller agrees, upon receiving full payment of the purchase price and interest in the manner above spedeed to the property, cified, to execute and deliver to purchaser a excepting such part thereof which may hereafter be condemned, if any, free of incumbrances except those above mentioned, and any that may accrue hereafter through any person other than the seller.

The seller has delivered, or within ten days herefrom will procure and deliver, to the purchaser, a title policy in usual form issued by the Puget Sound Title Insurance Company, insuring the purchaser to the full amount of said purchase price against loss or damage occasioned by reason of defect in, or incumbrance against, seller's title to the premises, not assumed by the purchaser, or as to which the conveyance hereunder

The parties agree: (1) to execute all necessary instruments for the extension of payment or renewal of said mortgage during the period prior to the delivery of said deed, or the termination of purchaser's rights by virtue of the provisions hereof, provided the seller shall not be obligated thereby to assume any personal obligation or to execute any mortgage providing for a deficiency judgment against the seller, or securing a principal indebtedness in excess of that now unpaid on the above mentioned mortgage or bearing an interest rate of more than two per cent greater than that of the original mortgage indebtedness; (2) that the purchaser has made full inspection of the real estate and that no promise, agreement or representation respecting the condition of any building or improvement thereon, or relating to the alteration or repair thereof, or the placing of additional improvements thereon, shall be binding unless the promise, agreement or representation be in writing and made a part of this contract; (3) that the purchaser shall have possession of the real estate on depte wer 9, 1956 and be entitled to retain possession so long as purchaser is not in default in carrying out the terms hereof; and (4) that, upon default, forfeiture may be declared by notice sent by registered mail to the address of the purchaser, or his assigns, last known to the seller.

Time is of the essence hereof, and in the event the purchaser shall fail to comply with or perform any condition or agreement hereof promptly at the time and in the manner herein required, the seller may elect to declare all of the purchaser's rights hereunder terminated, and upon his doing so, all payments made by the purchaser hereunder and all improvements placed upon the premises shall be forfeited to the seller as liquidated damages, and the seller shall have the right to re-enter and take possession of the property; and if the seller within six months after such forfeiture shall commence an action to procure an adjudication of the termination of the purchaser's rights hereunder, the purchaser agrees to pay the expense of searching the title for the purpose of such action, together with all costs and a reasonable attorney's fee.
