

*D-175 Item 2:* Lot 15, Whistler's Park Estates in Section 17, Township 26 South, Range 4 West, Willamette Meridian, as platted and as of record in Douglas County, State of Oregon.

*D-175 Item 3:* A tract of land in Lane County, State of Oregon, 100 feet in width, being 50 feet northeasterly and 50 feet southwesterly from, when measured at right angles to, the following described survey line:

Beginning at a point in the north line of a tract of land conveyed to Ralph S. and Rose B. Shelley by deed recorded in Book 257, Page 225, said point being 1724.03 feet westerly of the northeast corner of said tract; thence south  $50^{\circ} 17' 40''$  east 972.13 feet; thence south  $88^{\circ} 31' 00''$  east 1014.17 feet to a point 62.51 feet easterly of the east line of said tract; thence south  $2^{\circ} 35' 32''$  west 312.80 feet to a point in the south line of a tract of land conveyed to Ralph S. and Rose B. Beginning at a point on the north line of the Robert E. Campbell and wife Donation Land Claim No. 59, in Township 17, South, Range 3 West, Willamette Meridian, 2130 feet west of the northeast corner of said D.L.C.; thence south 710.6 feet; thence west parallel to the south line of said D.L.C. 75 feet; thence north 350 feet; thence west 75 feet; thence north 360.6 feet; thence east 150 feet to the place of beginning, which lies southerly of the property conveyed from Elmer L. Sunday and Erma L.
