Parcel #1: Beginning at a point 44.02 chains north and 8.34 chains south $87^{\circ} 30'$ east from the southeast corner of the M. H. Harlow Donation Land Claim No. 57, said Township and Range, and running thence south $87^{\circ} 30'$ east 8.51 chains to the east line of the John G. Day D.L.C. No. 58; thence south $0^{\circ} 17'$ west along said east line 5.88 chains; thence north $87^{\circ} 30'$ west 8.48 chains to a point due south of the place of beginning; thence north 5.88 chains to the place of beginning, EXCEPT that portion conveyed by that certain Deed from R. A. Elliott and Georgia Opal Elliott, husband and wife, to State of Oregon, by and through its State Highway Commission, dated January 27, 1960, recorded February 1, 1960, Recorder's No. 89750, Deed Records of said County and ALSO EXCEPT that portion conveyed to said Lane County, by deed dated March 14, 1960, recorded April 27, 1960, Recorder's No. 97727, Deed Records of said County.

Parcel #2: Beginning at a point which is opposite and 70 feet easterly of Station 31+00 on the center line of the southeasterly connection between the relocated Pacific Highway and the relocated Eugene-Springfield Highway, said point being 1199.4 feet south and 374.37 feet west of the northwest corner of the Robert E. Campbell D.L.C. No. 59, said township and range; thence north $47^{\circ} 56' 05''$ east, 108.42 feet to the east line of property described in deed recorded February 1, 1960, at Recorder's No. 89750 records of said County; thence south $9^{\circ} 05' 57''$ west, along the said east line 165 feet, more or less, to the south line of said property; thence westerly along said south line 69 feet, more or less, to a line which is parallel to and 70 feet easterly of said connection center line herein referred to; thence north $9^{\circ} 05' 57''$ east, along said parallel line 80 feet, more or less, to the point of beginning,
