

D-175 Item 14: That part of the following described tract of land, in Lane County, State of Oregon, which lies southerly and westerly of the southerly and westerly right of way line of the relocated Pacific Highway:

Beginning 12.40 chains north of the southwest corner of Donation Land Claim No. 38, Notification No. 3287 in Section 3, Township 18 South, Range 3 West, Willamette Meridian, running thence north 3.75 chains; thence west 8 chains; thence south 3.75 chains; thence east 8 chains to the place of beginning, except that part conveyed to the State of Oregon, by deed recorded in Book 389, at Page 137, records of said County.

D-175 Item 15: Two parcels of land in the west half of Section 3, Township 18 South, Range 3 West of the Willamette Meridian, in Lane County, State of Oregon, described as follows:

Parcel #1: Beginning at a point on the south line of the Charles B. Sweet Donation Land Claim No. 38 which bears south $88^{\circ} 03' 10''$ east 440.00 feet from the southwest corner of said D.L.C. No. 38; thence north $1^{\circ} 50' 44''$ east 166 feet; thence north $88^{\circ} 03' 10''$ west 40.00 feet; thence north $1^{\circ} 50' 44''$ east 238.30 feet to a point marking the southwest corner of "Parcel B" as described and recorded on Reel 174-61D, Instrument No. 35354, Deed Records of said county; thence south $88^{\circ} 03' 10''$ east along the south line of said parcel 24.00 feet; thence along the east line of said Parcel B north $1^{\circ} 50' 44''$ east 2.45 feet to a point in the south line of a one-acre tract as surveyed for H. N. Oberg; thence south $88^{\circ} 03' 10''$ east along said south line 56.00 feet; thence south $1^{\circ} 50' 44''$ west 241.75 feet; thence south $88^{\circ} 03' 10''$ east 60.00 feet to a three-quarter inch iron pipe marking the northwest corner of that property conveyed to Jack N. and Dorothy C. Baker recorded in Reel 84, Instrument No. 90586, Deed Records of said County; thence south $1^{\circ} 50' 44''$ west along the west line of said Baker property 165.00 feet to the southwest corner of said Baker property and a point in the south line of said D.L.C.
