*D-221 Item 2:* A tract of land in Walla Walla County, State of Washington, located in the southwest quarter of the northwest quarter of Section 22, Township 7 North, Range 36 East of the Willamette Meridian, described as beginning at the northeast corner of Lot 84 of Valley Homes, according to the official plat thereof of record in the office of the Auditor of said County, in Book "A" of plats at Page 81; thence north  $0^{\circ} 34'$  west 117.40 feet along the extended east line of said Lot 84; thence north  $69^{\circ} 54'$  west 38.97 feet; thence north  $62^{\circ} 36'$  west 194.80 feet; thence south  $55^{\circ} 40'$  west 108.75 feet; thence south  $4^{\circ} 40'$  west 162.50 feet to the north line of said Valley Homes; thence north  $89^{\circ} 30'$  east 313.65 feet along said north line to the point of beginning, EXCEPT the following described tract:

*D-222 Line:* From Walla Walla Substation (C-272) to connection with The Washington Water Power Company's line at the Columbia County-Garfield County Line in Section 4, Township 10 North, Range 41 East of the Willamette Meridian, all in COLUMBIA and WALLA WALLA Counties, State of WASHINGTON.

*D-223 Line:* From Hanford to a connection with The Washington Water Power Company at Taunton, all in ADAMS, BENTON, and FRANKLIN Counties, State of WASHINGTON.

*D-224 Line:* From Union Gap Substation (C-75) to Nob Hill Substation (C-273) to a connection to the Union Gap-Orchard Substation Line, all in YAKIMA County, State of WASHINGTON.
