feet, more or less, to deep water in Upper Klamath Lake; thence along the shore of the said Lake south 11° 46′ east 272.12 feet, more or less, to the most northerly point on the westerly boundary line of the tract of land described in the deed hereinabove referred to; thence along the northerly boundary line of tract conveyed by said deed, north 89° 23′ east 902 feet to the point of beginning.

Parcel 6.
