

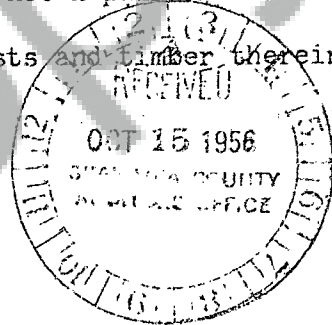
The Grantor, THURLO HARRIS, a single man, of Willard, Washington, for and in consideration of Ten Dollars and other Valuable Considerations in hand paid, conveys and warrants to ARTHUR MOORE and CHESTER F. TEAGUE, doing business under the firm name of Moore & Teague, all of the merchantable cottonwood timber standing and being upon the following described real property in Skamania County, State of Washington:

The North Half of the Northwest Quarter of the Southwest Quarter ($N\frac{1}{2} NW\frac{1}{4} SW\frac{1}{4}$), the North Half of the Southwest Quarter of the Northwest Quarter of the Southwest Quarter ($N\frac{1}{2} SW\frac{1}{4} NW\frac{1}{4} SW\frac{1}{4}$), and the Northwest Quarter of the Southeast Quarter of the Northwest Quarter of the Southwest Quarter ($NW\frac{1}{4} SE\frac{1}{4} NW\frac{1}{4} SW\frac{1}{4}$) of Section 2; the Northeast Quarter of the Southeast Quarter ($NE\frac{1}{4} SE\frac{1}{4}$), and the Northwest Quarter of the Northwest Quarter of the Southeast Quarter of the Southeast Quarter ($NW\frac{1}{4} NW\frac{1}{4} SE\frac{1}{4} SE\frac{1}{4}$) of Section 3; all in Township 4 North, Range 9 E.W.M.

Together with such rights of way thereon as may be reasonably necessary for access to, and the removal of, the above described timber. The grantees shall have until October 1, 1957, to cut, log and remove the timber hereby conveyed; and on October 1, 1957, all right, title and interest of the grantees in the timber then remaining on the above described real property shall cease and terminate and the same shall revert to the grantor, his heirs and assigns.

The Bank of Stevenson joins in this conveyance in order to release the above described cottonwood timber from the lien of a certain mortgage executed by the grantor dated February 17, 1956, and recorded at page 1 of Book 29 of Mortgages, Records of Skamania County, Washington; but such release shall not impair the validity of the said mortgage as to the other real property interests and timber therein described.

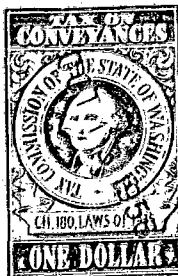
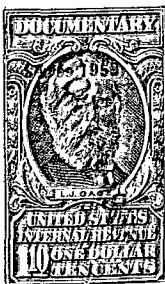

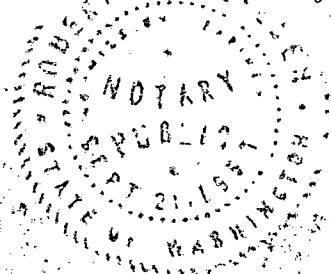
