## COMMUNITY PROPERTY AGREEMENT.

THIS AGREEMENT, Made and entered into this I7th day of May, 1956, by and between Donald E. Leer and Gladys K. Leer, husband and wife, residing at Stevenson, Skamania County, Sate of Washington, witnesseth:

That, whereas, said Donald E. Leer and Gladys K. Leer are the owners of certain real estate described as follows, to-wit:

Leer survives, the whole of said property hereinbefore described, together with any other property, including personal property, by them hereafter acquired, shall at once vest in said Glady K. Leer in fee simple, and in the event of the death of said Gladys K. Leer while the said Donald E. Leer survives, the whole of said property hereinbefore described, together with any other property, including personal property, by them hereafter acquired, shall at once vest in the said Donald E. Leer in fee simple.


