to-wit: Parcel No. 1. Commencing at a point on the east line of lot 1 of Stevenson Park Addition, according to the official plat thereof on file in the office of the Auditor of Skamania County, Washington, which is 300 feet south of the north line of said lot 1 extended east, thence southerly along the easterly line of said lot 1 a distance of 50 feet, thence west 110 feet to a point 100 feet west of the west line of Lateral Highway No. 3, thence North 50 feet, thence east 110 feet, more or less to the place of beginning.

Parcel No. 2. Also easement for road right of way along a strip of land along the southerly side of said tract and extending due east to intersection with the road known as Lateral Highway No. 3.

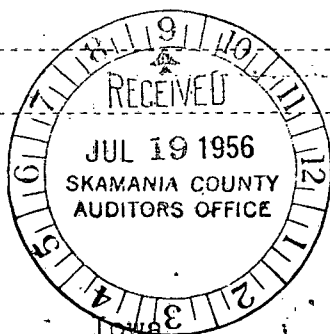
