O R D E R

November 19, 1956

It appearing to the Commissioner at this time that Application No. 2209 was filed in this office by the United States of America, Gifford Pinchot National Forest, for a right of way for an access road over government lot 1, S $\frac{1}{2}$ of NE $\frac{1}{4}$, NW $\frac{1}{4}$ of SE $\frac{1}{4}$, NE $\frac{1}{4}$ of SW $\frac{1}{4}$, W $\frac{1}{2}$ of SW $\frac{1}{4}$ and W $\frac{1}{2}$ of NW $\frac{1}{4}$ of section 4, township 7 north, range 5 east, W.M., in Skamania County; that said application was filed in accordance with the provisions of Chapter 145, Session Laws of 1945, providing for the granting of rights of way to the United States Government over State lands; and

It further appearing that rights of way 66 and 80 feet in width are desired; that there are no improvements on the right of way; that damages to the timber by reason of the granting of this right of way do not exceed the sum of \$3,384.00; that no good reason exists why this right of way should not be granted; and the Commissioner being fully advised, it is therefore

ORDERED and DETERMINED that the plat showing the survey of said right of way as filed with said Application No. 2209 be and the same is hereby approved as the official plat of said road; that damages by reason of the granting of said easement be and the same are hereby appraised at \$3,384.00; that said amount has been paid, and that an easement be and the same is hereby granted to the United States of America for a road over the following described lands:

Those portions of government lot 1, S $\frac{1}{2}$ of NE $\frac{1}{4}$, NW $\frac{1}{4}$ of SE $\frac{1}{4}$, NE $\frac{1}{4}$ of SW $\frac{1}{4}$, W $\frac{1}{2}$ of SW $\frac{1}{4}$ and SW $\frac{1}{4}$ of NW $\frac{1}{4}$ of section 4, township 7 north, range 5 east, W.M., included within the limits of two strips of land of variable widths, having the following described centerlines:

Beginning at a point on the south line of said section 4, which is 468 feet east of the southwest corner thereof, said point being on a curve to the left, having a radius of 600 feet, the tangent to said curve at said

point bears N 09° 05' 51" E, and running thence on said curve with a width of 33 feet on each side 36.3 feet, thence N 5° 35' E 293.9 feet; thence on a curve to the left, having a radius of 400 feet, 175.0 feet; thence N 19° 55' W 228.1 feet; thence on a curve to the right having a radius of 2000 feet, 314.2 feet; thence N 10° 55' W 135.5 feet; thence on a curve to the left having a radius of 2000 feet, 226.9 feet; thence N 17° 25' W 272.9 feet; thence with a width of 40 feet on each side and on a curve to the right having a radius of 100 feet, 90.3 feet; thence on a curve to the left having a radius of 100 feet, 116.1 feet; thence on a curve to the left, having a radius of 350 feet, 178.7 feet and thence N 61° 25' W 55.1 feet to a point on the west line of said section 4, which is N 0° 13' E 621.9 feet from the west quarter section corner thereof with an area of 3.37 acres; also

Beginning at a point on the west line of said section 4, which is N 0° 13' W 352 feet from the west quarter section corner thereof and running thence with a width of 40 feet on each side S 38° 10' E 211.3 feet, thence on a curve to the left having a radius of 160 feet, 107.5 feet; thence on a curve to the right having a radius of 100 feet, 74.2 feet; thence on a curve to the left having a radius of 223 feet, 215 feet; thence S 69° 25' E 14.4 feet; thence on a curve to the right having a radius of 75 feet, 125.3 feet; thence on a curve to the left having a radius of 130 feet, 180.6 feet; thence with a width of 33 feet on each side S 68° 40' E 204.4 feet; thence on a curve to the left having a radius of 300 feet, 123 feet; thence N 87° 50' E 48.1 feet; thence on a curve to the right having a radius of 400 feet, 347.3 feet; thence S 42° 25' E 173.3 feet, thence on a curve to the left having a radius of 900 feet, 255.5 feet; thence on a curve to the left having a radius of 150 feet, 154.5 feet; thence N 63° 20' E 916.7 feet; thence on a curve to the right having a radius of 400 feet, 111.7 feet, thence N 79° 20' E 40.5 feet; thence on a curve to the left having a radius of 400 feet, 207.2 feet; thence N 49° 35' E 406.1 feet; thence on a curve to the left having a radius of 1000 feet, 209.4 feet; thence N 37° 35' E 550.3 feet; thence on a curve to the left having a radius of 1000 feet, 270.5 feet; thence N 22° 05' E 677 feet; thence on a curve to the right having a radius of 600 feet, 280.1 feet; thence N 48° 50' E 71.9 feet; thence on a curve to the left having a radius of 1000 feet, 584.7 feet and thence N 15° 35' E 378.3 feet to a point on the north line of said section 4, which is west 66.1 feet from the northeast corner thereof with an area of 11.74 acres;

The total area of the above two rights of way is 15.11 acres according to the plat thereof on file in the office of the Commissioner of Public Lands at Olympia, Washington.
