



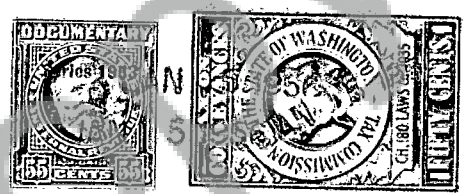

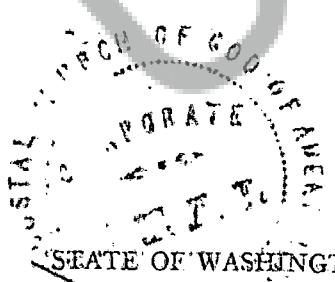

 the following described real estate, situate in the county of **Skamania** state of Washington:

Beginning at a point on the north line of the 400 foot right of way of the Spokane, Portland & Seattle Railway Company, which said point is south 48' east of an point 50 feet due east of a round hub placed at an angle point in the northerly line of said railway right of way, north 9° 5' east 200 feet from Station 2042 + 23.4 of survey locating the center line of said right of way, said round hub being 997.92 feet south and 2035.5 feet west from the northeast corner of Section 21, Township 2 North, Range 7 E. N.M.; and running thence easterly along the north line of said right of way to its intersection with a line running south 48' east from a point 100 feet due east of said round hub; thence north 48' west to the south line of Roosevelt Avenue as shown upon the unrecorded plat of North Bonneville; thence north 71° 40' west along the south line of said Avenue to a point which is north 48' west of the place of beginning; and thence south 48' east to the place of beginning; said tract being designated as the east 50 feet of the west 100 feet of Lot 1 in Block 9 of the unrecorded plat of the Town of North Bonneville, Skamania County, Washington.

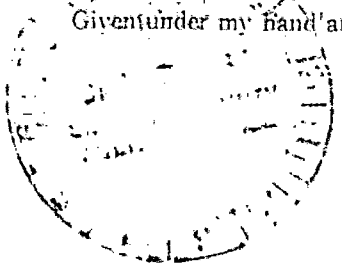

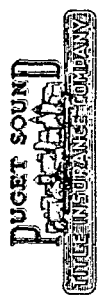
